



## **Corinthians Badminton Club 2018 AGM Minutes 31<sup>st</sup> May 2018**

### **2. Minutes of 2017 AGM**

A copy of the minutes was posted on the club website and everyone notified prior to the meeting. These were approved unanimously. Proposed by Brendan Goffin and seconded by Sue McKinley

### **3. Matters Arising**

Bob stated that we still had the future of the Club as a standing Committee item but no great ideas to date and that sponsorship, other than the £250 form N-Power, had not been progressed but was still an option that we had not ruled out.

### **4. Secretary's Report**

This AGM concludes my first year as Club Secretary, all things considered a reasonably smooth ride too.

As in the previous season the club fielded 12 teams in the IDBL, comprising of 6 mixed teams, 4 men's teams and 2 ladies teams. Once again, the most teams fielded by a single club. Fortunately, in order to field that number of teams we have a strong and growing membership. This season we registered 57 players (up 9 on the previous year). That includes 3 juniors and 5 coaches.

Thanks, as always to Brendan for sorting all the fixtures – never an easy task; 12 teams mean fitting in 72 home matches in 26 match nights!

The club entered the Playford Trophy this year, but with a handicap based on the previous year's results (where of course we won all three Div 1 titles) we lost in the first round to Meadlands – who went onto be the runners up – losing to Belstead & Ransomes.

Eleven players from Corinthians entered the IDBL Championships and Veterans Tournament in late April – that's more than any other club. Dan Moss won the Championships singles title for the 5<sup>th</sup> time and then went on to win the mixed title with Claudette. In the Veterans tournament, Mike Laker (playing with Mike Tee from the YM) won the Mens doubles event beating Bob (playing with Gareth Ward also from the YM). In the Mixed event Gill Harris (playing with Mike Tee) beat Mike Laker and Sue McKinley.

The committee met on three occasions; July to prep for the new season, January to check on how the season was progressing and April to finalise the season. That said there are numerous conversations and emails that result in the smooth running of the club.

Bob also arranged another series of coaching evenings which were well received.

Outside of Badminton the club try to encourage a wider social gathering and Sue McKinley has arranged a couple of curry nights and the Christmas meal, and Mitch is arranging a Brewery trip in June.

The Suffolk Badminton AGM took place on the 14<sup>th</sup> May which I attended. Not the most interesting of meetings and very little to report coming out of it. SBA are increasing its adult subscription by 25p (juniors unchanged). There is no clear indication of what BE will do with their subs, however there was a general feeling that we should expect an increase of £1 per adult.

Finally, a brief mention around GDPR (General Data Protection Regulations). You may well have been receiving a flurry of emails from various organisations requesting you to confirm that you "keep in touch" and reconfirm your subscription to email updates. You will have also realised that we have only issued a reminder of the data we hold and why. The data we hold – i.e. contact details and BE registration information is needed by the club on the grounds of it being Vital and Legitimate Interests. However, in preparation for the new season I will be writing to all members detailing what specific data we hold, asking you to confirm it is accurate, explain why we hold it, how it will be used.

## **5. Treasurer's Report**

### **Overview**

We have managed to make an operational surplus of £936 for the last financial year. This effectively cancels out the loss of £1000 we made in the previous year and allows the club to go forward on a sounder financial basis.

### **Income**

Our income for last financial year was £13,336. This represent an increase on the previous year of approximately £2000. The increase is a result of small increases in membership and match fees together with an increase in membership levels. We also benefitted from a better

performing summer club and a generous £250 grant from UK Power Networks (thanks to Paul Cant for obtaining this).

### **Expense**

Our expenditure for last financial year was approximately the same as the previous year at £12,400. Most of our costs for last year were very similar to the year before apart from shuttle costs, where we used more shuttles than previously.

### **Summer club**

Summer club (2017) ran from April through to September and made a small overall profit of approximately £600.

### **Shuttles**

We spent £500 more on shuttles last year than in the previous year. This represents about 25 tubes of shuttles.

- a. Darryl Morgan
